## SECONDARY SCHOOL-AGE NASAL FLU VACCINATION

The School-Age Immunisation Service is delivering the flu immunisation programme in Cornwall's and Devon's schools on behalf of NHS England & Improvement. Flu can be a very unpleasant illness and sometimes causes serious complications. Vaccinating your child will also help protect more vulnerable friends and family by preventing the spread of flu.

In 2023/24 all students in secondary schools in Years 7 – 11 will be offered the vaccine. The vaccination is free and recommended for children and young people; it is administered by a quick and simple spray up the nose. Please submit your consent by midday on 12th December 2023 to ensure your child receives their vaccination. If you experience any problems accessing the form please telephone 01872 221105 for Cornwall schools and 01392 342678 for Devon schools, and the team will be happy to help. Please note that as in previous years you must opt in to the programme. If a consent form is not submitted your child might not be vaccinated.

 Important: Your child can self-consent to treatment if they are considered competent to do so by one of our nurses; this is known as Gillick competency.
