## Tetanus/Diphtheria/Polio and Meningitis ACWY

**Do you have a child in year 10 or 11? Did they receive their Tetanus/Diphtheria/Polio and Meningitis ACWY vaccines in year 9?**

- These are very important vaccines which will usually complete the routine childhood vaccinations, providing boosters from when your child was pre-school.
- If you are unsure, please call the team on **01872 221105 for Cornwall schools and 01392 342678 for Devon schools** and we will be able to advise. **If you have consented and now wish to withdraw consent, please contact Kernow Health in the first instance.**

- We will be visiting the school **on 18<sup>th</sup> and 19<sup>th</sup> January 2024** and again later in the year as well as running some community catch-up clinics at various venues around the counties. We will give every opportunity for you to have your child immunised. Please submit your consent form by **midday on 16<sup>th</sup> January 2024** in order to ensure your child receives their vaccination.
- **Your child can self-consent to treatment if they are considered competent to do so by one of our nurses; this is known as Gillick competency. If you require any further information in this regard, please contact us or go to <https://www.nhs.uk/conditions/consent-to-treatment/children/>**
